AFFIDAVIT OF TAX COLLECTOR

BEFORE ME, the undersigned official, on this day appeared PAULA LOWRIE, who is known personally to me, and being first duly sworn according to law upon her oath deposed and said:

My name is PAULA LOWRIE, I am over 18 years of age, and I am fully competent to make this affidavit. I have personal knowledge of the facts stated herein and they are all true and correct.

That in my position as Chief Appraiser of the City of Howardwick, I am the lawful custodian of the delinquent tax roll(s) for all said taxing unit(s) and that I have the everyday care, custody, and control of said delinquent tax roll(s).

That I have examined the delinquent tax records for the City of Howardwick and the property descriptions and last appraised values for the properties sought to be seized and sold are listed on Exhibit A attached to the Application for Tax Warrant and said official records are incorporated by reference. That the taxes on the properties on said Exhibit A are delinquent for each of the preceding five years or preceding three years and a municipal lien recorded to at least one of the taxing units collected by the Donley County Appraisal District and are calculated to reflect December 2019 amounts.

That the properties described in said Exhibit A are located within the City of Howardwick, Donley County, Texas.

That seizure of the property for the delinquent taxes, penalties, and interest is in the best interest of the City of Howardwick the other taxing units and that the sum of said claims, when added to the cost of a standard judicial foreclosure, exceeds the anticipated proceeds from a tax sale.

That notices for each delinquent tax year were sent to the owners as shown on the attached Certificate of Service on the appraisal roll of each property as required by the Texas Property Tax Code §31.01. For those owners and interest holders we were unable
